Offered Benefits for Out Patient & In Patient department to Students, Staff & Staff Dependants:-

The below Corporate Discount Structure will be applicable to **Indian Institute of Education & Business Management (IIEBM)** Students, Staff & Staff Dependants.

OPD: -

- 1) **Free Registration.**
- 2) **25% discount** for Consultation on prevailing tariff in out patient department (**OPD**).
- 3) **10% Discount** on Laboratory & Radiology Investigations on prevailing Hospital Tariff in out patient department (**OPD**).

IPD: -

- 4) **10% Discount** on In Patient department (Excluding Consumables, Packages, Medicines & Doctor fees) on prevailing Hospital Tariff in following criteria :
 - a) Bill to Institute, Credit Bills,
 - b) Cash payment by Students, Staff & Staff Dependants.
- 5) **10% discount** on ongoing wellness assessment Centre packages.
- 6) The discounts mentioned out under clause 2, 3 & 4 shall not be applicable for Patients who are covered under the Medical Insurance Policy/TPA.

Beneficiary should provide their Company Identity Cards for themselves and Authorization Letters/Self Authorization for their Dependants to avail the discounts before the bills are generated.



MEMORANDUM OF UNDERSTANDING

- 1) Aditya Birla Hospital would be providing Out Patient department & In Patient department Health services to the beneficiaries of **Indian Institute of Education & Business Management (IIEBM)**.
- 2) **Indian Institute of Education & Business Management (IIEBM)** Students, Staff & Staff Dependants should carry respective institute ID card or an authorization letter from the authorized personnel of their institute or an email from the authorized personnel prior arrival to the Hospital.
- 3) Credit facility for **Indian Institute of Education & Business Management (IIEBM)** Students, Staff & Staff Dependants for In Patient department, Out Patient department letter from the institute or mail is mandatory. Credit facility users can avail the above Discount structure.
- 4) In case of emergencies your beneficiaries would require to produce the letter within 24 hours of the next working day from the time of admission.
- 5) In case any individual Students, Staff & Staff Dependants opts for higher category accommodation than his/her entitlement, then the difference of the entire charges of the higher category has to be borne by the Students, Staff & Staff Dependants in case at the time of discharge.
- 6) Bills for the hospitalization should be settled by the concerned patient at the time of discharge. **Indian Institute of Education & Business Management (IIEBM)** will settle only those bills for which specific written requests i.e., through an authorization letter duly signed by the nominated authorized signatory of the Institute for the hospitalization of such patients (student/staff). The bills for such cases would be settled within 30 days of receipt of hospital bills.
- 7) For cash payee Students, Staff & Staff Dependants, the corporate discounts would be extended to Students & Staff only upon producing a valid ID card of the institute and for their dependents - a valid authorization letter from their institute would be required.
- 8) The credit facility would remain suspended if accounts are not settled within the allowed credit period.
- 9) For all the indoor and outdoor treatment, payment should be made by cheque in favor of "**Aditya Birla Health Services Ltd.**- Collection A/c".



- 10) All the hospital charges shall be as per the prevailing hospital schedule of charges. Whenever there is any revision in the schedule, such revised schedule of rates shall be applicable from the date of such revision.
- 11) This MOU shall be in force for a period of Two year from the date of signing.
- 12) Ambulance only will be provided by **ABMH** on phone call request by Indian Institute of Education & Business Management (IIEBM) it will be solely decision of Indian Institute of Education & Business Management (IIEBM) to call which Cardiac or Non Cardiac Ambulance. The charges of the Non Cardiac Ambulance will be for the first 3 kms will be Rs 500/- & there after each km will be changed @ Rs 50/km and the charges for Cardiac Ambulance will be for the first 10 kms will be @ Rs 17850/- and there after each km will be charged @ Rs 75/km.
